#### **COURSE OVERVIEW**

This unit of competency describes the skills and knowledge required to safely operate a hand-held chainsaw and maintain it in working condition.

This unit applies to cross-cutting fallen timber using safe cutting techniques.

The unit applies to individuals who apply low risk work procedures and comply with worksite health and safety requirements when operating hand-held chainsaws to carry out routine work.



No occupational licensing, legislative or certification requirements apply to this unit at the time of publication.

#### **COURSE CONTENT**

### Assist in preparation of worksite

- Identify location of worksite and fallen timber & site hazards
- Confirm first aid personnel, equipment and procedures
- Document and implement site health and safety in the workplace, environmental and traffic control measures

# Recognise and apply workplace safety procedures

- Identify hazards and risks relevant to the maintenance and operation of chainsaws and implement safe working practices to manage risks
- Select, fit and use personal protective equipment according to workplace safety procedures
- Confirm with supervisor relevant licensing and legislative requirements with regard to the operation of chainsaws
- Transport chainsaw safely according to operation and maintenance manual

# Check and prepare chainsaw for use

- Conduct routine checks and maintenance prior to operation
- Calculate required fuel oil ratios & mix fuel
- Identify, tag, record and report chainsaw faults or malfunctions to supervisor

# Operate chainsaw

- Communicate with work team
- Place supports to ensure a stable base for cutting
- Identify materials to be cut, visually assess for defects and position them for operation
- Determine cutting methods appropriate to material type and implement risk controls
- Operate chainsaw to cross-cut timber
- Report communication issues & environmental impacts to supervisor

# Complete and check chainsaw operation

- Record and report chainsaw damage, malfunction and irregular performance
- Clean and store chainsaw
- Dispose of debris from operation
- Maintain workplace documentation

- Be at least 18 years of age (Photo Identification is required to be sited prior to course commencement.)
- **USI** Number
- Arrive in suitable clothing (long pants, closed-in shoes, long sleeve shirt)
- There are no pre-requisites for this unit

- Language, literacy and numeracy skills required to interpret legislative requirements and to undertake written and practical assessment activities
- Students must wear safety boots, long pants, long sleeved shirts. Students must also provide their own PPE e.g. face shield, helmet, hearing protection and chaps.
