COURSE OVERVIEW

This unit of competency covers the skills and knowledge required to test the working atmosphere using electronic test apparatus to find out if it is safe for the proposed work. The unit is suitable for use when working in confined spaces, enclosed and partially enclosed spaces, hot work, storage tanks, silos, pits, pipes, shafts, ducts, transport vehicles and ships. This unit of competency applies to an individual working alone or as part of a team or group and working in liaison with other shift team members and the control room operator, as appropriate. This course is run from a state-of-the-art confined space training facility and is designed with focus on practical scenarios and assessments, as well as classroom-based theory delivery.



COURSE CONTENT

Prepare for gas testing

- Find out type of gas/ atmosphere to be tested
- Select and calibrate equipment in accordance with procedures (including emergency procedures, work instructions, SWMS, etc.)
- Find out gas testing regime/sampling pattern required
- Identify hazards from possible atmosphere contaminants
- Implement hazard control measures and use of appropriate PPE

Test gas

- Use gas testing equipment and test gas as required
- Interpret and report readings
- Monitor gas on an ongoing basis

- Take required action if readings are unacceptable
- Apply known solutions to routine problems such as changes in readings, unexpected readings, faults in equipment
- Communicate required actions to be taken to appropriate personnel

Maintain equipment

- Clean and maintain gas testing equipment in accordance with procedures
- Inspect and fault-find monitoring equipment
- Return gas testing equipment to required location and in required condition
- Maintain records of tests and results

ENTRY REQUIREMENTS

- Be at least 18 years of age (Photo Identification is required to be sited prior to course commencement.)
- USI Number
- Be fit and able to climb and crawl
- Not have a fear of heights or confined spaces
- Arrive in suitable clothing (long pants, closed-in shoes, long sleeve shirt)
- Language, literacy and numeracy skills required to interpret legislative requirements and to undertake written and practical assessment activities
