



# Perform Tower Rescue

## COURSE OVERVIEW

The application of this unit in the workplace covers the performance of rescue procedures from an Electricity Supply Industry tower in the work place. It specifies the mandatory requirements of rescue from an ESI tower and how they apply in the context of transmission, distribution or rail work functions. It encompasses responsibilities for, health, safety and risk management processes at all operative levels and adherence to safety practices as part of the normal way of doing work.



## COURSE SUBJECTS

### Prepare to perform tower rescue

- Instruction in hazards and risk control measures for specific work areas and work activities are identified and obtained. (This will include the risk assessment and control measures taken by the individual performing the rescue).
- Tools and emergency equipment are checked for safety, functionality and placed in an accessible location to facilitate response and rescue according to established procedures.

### Carry out tower rescue

- Workplace procedures and work instructions for controlling risk are followed.
- Workplace procedures for accessing the tower, removing the victim, where necessary, from contact with live apparatus and are followed.

- Workplace procedures for attaching the emergency lowering equipment and lowering the victim to the ground are followed.
- Workplace procedures for carrying out CPR if required at the site and treatment where necessary by medical professionals are followed. The worksite is secured and entry controlled until appropriate authorities inspect and release the site.

### Complete performance of tower rescue procedure

- Processes for reporting to accidents and/or incidents to authorised personnel are confirmed in accordance with established procedures.

## ENTRY REQUIREMENTS

- Be at least 18 years of age (Photo Identification is required to be sited prior to course commencement.)
- USI Number
- Be fit and able to climb and crawl
- Not have a fear of heights
- Arrive in suitable clothing (long pants, closed-in shoes, long sleeve shirt)
- Language, literacy and numeracy skills required to interpret legislative requirements and to undertake written and practical assessment activities

## PRE-REQUISITES

Students enrolling into this course must hold current competency in:

- HLTAID009 Provide cardiopulmonary resuscitation (obtained within 1 year of course date)
